Updates to DLS went live on the 18th May, including fixes, enhancements and new features. Here in brief is what's included:

### Fixes

- Fixes to validation of mandatory centre registration fields
- Fixed bug with non-standard sizing of learning content being displayed with scroll bars

### Enhancements

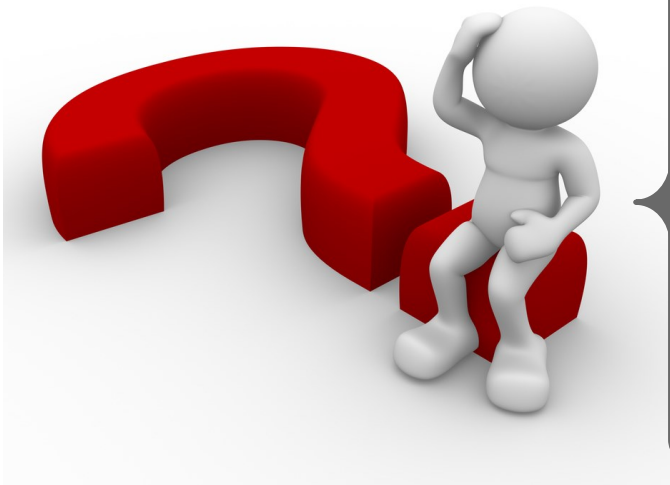
- Improvements to the Course Setup interface

### New Features

- Previewable learning content on the pre-login website (see Learning / Reasonable Adjustment Flag)
- CC course completion email to admin email address added to Course Setup
- Bulk send welcome email addresses from Delegates / All Delegates
- Schedule supervision sessions for supervised delegates (NOTE: This is beta functionality and support is only available for identified beta testing sites)

How do I?

*Q. A learner from our organisation has registered at the wrong DLS centre, what can we do?*

**A. Advise the learner to re-register** and pick the correct centre from the centre pick list during registration. It may be appropriate to confirm to the learner the DLS centre name. The learner should then use the **new delegate ID** provided at registration to log into their account and disregard any previous IDs.

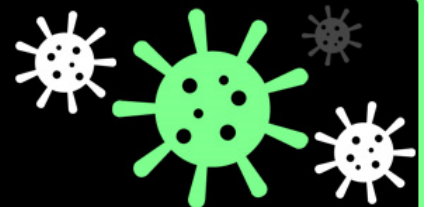
Existing customers can continue to use their licences as usual, receive support via our ticket system and we will continue to deliver any outstanding training.
