## Completion statistics - applying customisation changes to an existing course

We have made a few alterations within the tracking system recently particularly to do with course customisations. This can be a complicated topic for centres so please find some detailed information below about how altering existing courses will affect your learners.

If you wish to make changes to a course that delegates have already accessed, we always recommend that you create a new course instead. Making changes to a course that has already been published can have unforeseen consequences for the delegates who have already accessed it. Some of these are detailed below.

### Switching on post learning assessments in an existing course

If you have created a course, setting completion criteria other than post learning assessment completion, and learners have met these criteria and completed the course, their completion status will be reset if you subsequently switch on the post learning assessment. This cannot be undone.

The following warning will be displayed;



Clicking OK will confirm your changes and reset delegates' completion. Clicking cancel will return you to the course customisation form without saving your changes.

### Switching off post learning assessments in an existing course

If you switch off post learning assessments for a course, any delegates who have passed the assessments and completed the course will no longer be able to access their certificate.

### Making any other changes to a course with active delegates

If any other change is made and there are active delegates against the course, the following warning will be displayed;
